REGISTRATION

COURSE EXEMPTION:

Experienced professionals may be eligible to demonstrate their competence and expertise through recognition of prior learning (RPL). Initially, applicants will be asked to send a detailed CV, and any relevant transcript, to ascertain suitability. If accepted the applicant will then receive the RPL kit to record their evidence and supporting portfolio.

Applicants may also demonstrate their eligibility for credit transfer (CT) by providing statements of attainment awarded by other Registered Training Organisations.
